

hundreds of services that are delivered by eight operating departments. The total expenditure amount to provide these services is \$91.4 million.

GENERAL FUND REVENUES

The Town's General Fund revenue comes from a variety of sources. Approximately 22.9% of all annual General Fund revenue is from Real Estate Taxes. The remaining revenue sources include licenses and permits, charges for service, and intergovernmental revenues.

MEALS TAX

For every \$10 of prepared food purchased consumers pay \$0.60 in meals tax.



SALES TAX

For every \$10 of purchases, residents, businesses, and visitors pay \$0.53 in sales tax. Of this amount the town receives \$0.01.

REAL ESTATE TAXES

For every \$100 of assessed property value, owners pay \$0.26 in Real Estate



Taxes to the town, the county levies additional real estate taxes for schools and county-wide services.

HOTEL TAX

For every \$100 spent on a hotel room visitors pay \$7 in hotel tax.




MISCELLANEOUS REVENUES

Includes investment earnings, bond proceeds, and use of fund balance.

GENERAL FUND EXPENSES

The General Fund pays for various services such as police, fire, rescue, and parks and recreation. For FY 2023, the total General Fund budget is \$43.6 million.





UTILITY FUNDS

The Town of Blacksburg provides public water, operates the sewer collection system, collects trash and recyclable materials, and manages the stormwater systems. Fees collected each month from customers pay for the services; no taxes are used. Because of significant infrastructure improvements to the water treatment plant, combined water and sewer rates are increasing \$0.68 per thousand gallons. Solid waste fees are increasing \$1.50 to \$28.50 per month.

TRANSIT FUND



Blacksburg Transit, operated by the town, serves Blacksburg, Virginia Tech, and Christiansburg. Funding comes from Federal and State grants, in addition to local funds received from Virginia Tech and Christiansburg. The FY 2023 Transit budget is \$20.1 million.




FY 2023 CAPITAL IMPROVEMENT PROJECTS

The town prepares a Five-Year Capital Improvement Program (CIP) each year for significant infrastructure, equipment, and property acquisition. The CIP is a plan which takes into consideration projected growth, maintenance of existing infrastructure, and potential funding. The FY 2023 CIP includes \$24.1 million in projects.
